The Royal Children's Hospital

The Royal Children's Hospital's (RCH) vision is A world where all kids thrive.

RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.

RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. A full range of paediatric and adolescent health services are provided plus tertiary and quaternary care for the most critically ill and medically complex patients in Victoria. Tasmania, southern NSW and other states around Australia and overseas. The RCH is the only provider of heart transplant services and CAR T-cell therapy for paediatrics in Australia. RCH is an effective advocate for patients and their families with a particular focus on vulnerable children and increasingly, mental health in young people. The hospital also supports many health promotion and prevention programs. The Hospital has more than 6,000 staff, a budget of \$850M, 12 wards and 350 beds. Annually, the RCH has 300,000+ Specialist Clinic appointments, 90,000+ Emergency Department presentations and 20,000 elective surgeries.

ROLE CONTEXT

The Complex Care Hub is an interdisciplinary service established to lead and coordinate the health care experiences for complex patients and their families. Patients with complex needs frequently require multiple teams, advanced technology and medical equipment to support their care needs, both within the hospital and at home.



ROLE PURPOSE

The purpose of this role it to provide advanced trainees in paediatrics with experience and training in chronic and complex care. Approximately half of the children supported by the service will have complex neurodisability, the remainder a variety of other complex surgical and medical conditions. The successful applicants will work closely with, and provide support to, the Royal Children's Complex Care Hub team that comprise nursing, allied health, medical and administrative staff. The key purpose of the role is to assist in the medical care of these children, working with their generalist medical case managers, and providing timely assessments and advice to their families. The role will work closely with the team in Hospital in the Home and there will be opportunities for experience in this expanding area of paediatric care.

The role will involve supervision and mentorship of Junior Medical Staff (JMS), particularly around the management of this cohort of children when they are inpatients. Another facet of the role will be working across RCH to assist in identifying children with unmet support needs and working with other teams to promote an improved model of care for this patient group. There are opportunities for wide clinical experience, teaching, research and administration.

KEY ACCOUNTABILITIES

Clinical care

Apply evidence-based practice principles in clinical assessment, diagnosis, treatment planning and management.

Actively understand and apply the principles of informed patient consent.

Demonstrate and maintain competency in basic life support techniques.

Maintain accurate and timely clinical documentation and record-keeping as per organisational policy/procedures.

Participate in intake and patient review meetings for the Complex Care Hub

Work in outpatients alongside the consultant paediatricians providing medical case management for children including initial needs assessments and planned and semi urgent review appointments as required, completion and updating of care records as required, written communication with other members of the child's treating team

Provide medical supervision in the Day Medical Unit on weekends in rotation

Opportunity if appropriately experienced to work in the Neurodevelopment and Disability on call roster with Consultant supervision

Collaborative practice

Demonstrate increasing clinical leadership and autonomy in clinical decision-making appropriate to role and practice context.

Work effectively and collaboratively as part of a multidisciplinary team to establish common treatment goals and to develop and offer best care to children and families, ensuring that patient care is integrated and effective.

Escalate issues outside of scope of practice to senior medical staff and/or other health professionals as appropriate.

Communicate effectively with patients and families to ensure their understanding, and that their needs and views are included in treatment, care plans and actions.

Establish therapeutic relationships with patients and families that are goal directed and recognise professional boundaries and power imbalances.

Ensure effective communication with other staff and respond appropriately to communication and interpersonal challenges.

Demonstrate a solid understanding of systems-approaches to continuous quality improvement, including the role of organisation-wide accreditation via the Australian Commission of Safety and Quality in Health Care's (AHSQHC) - National Safety and Quality Health Service (NSQHS) Standards.

Identify areas of clinical practice for potential quality improvement.

Actively participate in and/or lead the review of policies, procedures and protocols and other quality improvement initiatives (as directed), including clinical audit and review meetings.

Other

Adhere to all occupational health and safety requirement of the role and workplace, including if/when working remotely.

Complete other duties as directed consistent with the individual's skill level and classification.



QUALIFICATIONS AND EXPERIENCE

Eligibility for general registration as a medical practitioner with the Australian Health Practitioners Regulation Agency (Ahpra) at the commencement of clinical training year. Must have AHPRA general registration prior to commencing in role.

This position is appropriate for a senior Advanced Trainee in paediatrics and would suit someone with an interest in general paediatrics or in developmental medicine. This is an ideal position as a bridge from a trainee paediatric position to consultant paediatric practice.

KEY SELECTION CRITERIA

- Eligibility for general registration as a medical practitioner with the Australian Health Practitioners Regulation Agency (Ahpra) at the commencement of clinical training year. Must hold general registration prior to commencing in role
- Record of academic achievement
- Appropriate level clinical skills commensurate with Registrar level
- Well-developed communication and interpersonal skills with demonstrated ability to work in a team environment
- Well-developed self-management and organisational skills, and evidence of personal resilience
- High level professional and ethical behaviour
- Demonstrated skills in paediatric medicine and an interest in children with medical complexity and disability

OTHER REQUIREMENTS

- Employees are required to undertake a National Criminal Record Check and a Working with Children Check prior to commencing employment.
- Employees are required to maintain a valid Working with Children's Check throughout their employment.
- A current, full drivers' licence for the State of Victoria which is appropriate for the type of vehicle being driven, and comply with any restrictions on their licence (e.g. wearing glasses) while undertaking hospital duties (If applicable)
