<p><b>The Royal Children's Hospital</b></p> <p>The Royal Children's Hospital's (RCH) vision is A world where all kids thrive.</p> <p>RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.</p> <p>RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. A full range of paediatric and adolescent health services are provided plus tertiary and quaternary care for the most critically ill and medically complex patients in Victoria, Tasmania, southern NSW and other states around Australia and overseas. The hospital also supports many health promotion and prevention programs. The Hospital has more than 6,000 staff, a budget of \$850M, 12 wards and 350 beds. - Develop and provide medical care to patients from the Department of Gastroenterology and Clinical Nutrition particularly in liver disease and liver transplantation
- Attendance at liver and general gastroenterology outpatient sessions as directed
- Attendance at liver and liver transplantation related multidisciplinary meetings
- Clinical care of inpatients with gastroenterological, nutritional and liver disease
- Clinical care of patients being evaluated before and after liver and intestinal transplantation
- Procedural responsibilities within the scope of practice including diagnostic and therapeutic gastrointestinal endoscopy.
- Contribution to on call and recall duties as directed
- Accurate and appropriate medical record keeping
- Time management and completion of administrative duties related to employment

#### QUALIFICATIONS AND EXPERIENCE

##### Essential:

- Specialist Medical Registration with AHPRA is required
- FRACP or equivalent or eligible for FRACP
- Postgraduate training and experience in paediatric gastroenterology
- Demonstrated experience and training in the care of patients with liver disease and liver transplantation
- Training in Paediatric Gastrointestinal Endoscopy approved by the Conjoint Committee

##### Desirable:

- A research qualification eg PhD, MD or Masters in Medicine will be considered favourably.
