Member Biographies

Professor Robyn Langham (Chair)

Professor Ed Oakley M.B.B.S, FACEM

Ed Oakley is a paediatric emergency physician and Chief of Critical Care at The Royal Children's Hospital Melbourne, Clinical Professor with the University of Melbourne, and an Honorary research fellow at MCRI. His research interests include providing evidence for emergency care of children, incorporating best care into clinical practice in emergency departments, and system monitoring to highlight variation in care and ensure sustainable change. He is a researcher in the Paediatric Emergency Medicine Centre of Research Excellence in Australia, which has research capacity building and fostering the next generation of researchers as a core goal. His research is conducted through the Paediatric Research in Emergency Departments International Collaborative. Professor David Amor

Zeffie is currently the Director of the Victorian Infant Hearing Screening Program at the Royal Children's Hospital's Centre for Community Child Health, a senior clinical psychologist with the Royal Children's Hospital's Department of Adolescent Medicine and Department of Neurology, and a research officer with the Murdoch Children's Research Institute.

Dr Laila Ibrahim

Laila Ibrahim is a Consultant Paediatrician in General Medicine at the Royal Children's Hospital Melbourne (RCH), Clinician Scientist-fellow at the Murdoch Children's Research Institute (MCRI) and Honorary Lecturer at the University of Melbourne (UoM). Her main research interest and vision is in avoiding unnecessary hospitalisation in children. For her PhD, she conducted a randomised controlled trial (RCT) of home versus hospital intravenous antibiotics in children and developed a clinical scoring system to determine which children with cellulitis should be treated with intravenous antibiotics, both of which had an immediate translation into clinical practice and incorporated into national and international clinical guidelines. She leads single site and multi-site research studies, answering research questions relevant to paediatric clinical care.

Dr Jonathan Payne

Associate Professor Jonathan Payne is co-group leader of the Brain and Mind Research Group at the Murdoch Children's Research Institute, a senior clinical neuropsychologist at the Royal Children's Hospital and an Honorary Principal Fellow in the Department of Paediatrics, University of Melbourne. His research aims to increase understanding of the neurobiological mechanisms underlying complex neurodevelopmental disorders by studying the cognitive, behavioural, and neurobiological phenotypes that arise in monogenetic syndromes.

A/Prof Claire Von Mollendorf

A/Prof Claire von Mollendorf is a medical epidemiologist currently working as a principal research fellow in the New Vaccines and Asia-Pacific Research Groups at the Murdoch Children's Research Unit (MCRI). She is Team Leader for the New Vaccines Group and is a member of the Melbourne Children's Global Health Leadership team.

She has been with MCRI since 2017 and over this period has predominantly led and managed adult and paediatric pneumonia surveillance studies in Mongolia exploring the impact of the pneumococcal conjugate vaccine. She also provides support for other projects in the Asia-Pacific Region and is the project manager for the NHMRC Centre of Research Excellence for Pneumococcal Disease Control in the Asia-Pacific grant. She is a co-principal investigator for the Australian site of three COVID booster vaccine studies funded by CEPI. She has an honorary appointment as a Principal Fellow within the Department of Paediatrics, University of Melbourne. She has supervised different levels of postgraduate students and published as an author and co-author on pneumococcal disease and other topics in peer reviewed journals. Her passion and involvement in research spans over a 20+ year period and projects have included adults and children, some vulnerable groups and ranged from clinical trials to observational studies.

Ken Knight

Ken Knight is Head of Research Impact & Consumer Involvement at the Murdoch Children's Research Institute, where he leads an award-winning program to build capacity, capability and an enabling culture for research translation, co-production and impact. He is an active researcher across the Melbourne Children's Campus, including as Chief Investigator on a number of research projects within the Gender Research and Mental Health Programs. Ken is an Honorary Senior Fellow in the Department of Paediatrics at The University of Melbourne, where he also teaches approaches to impact and engagement within the Faculty of Medicine, Dentistry and Health Sciences. He is Chair of the Association of Australian Medical Research Institutes' Impact Committee - where he co-developed the first Research Impact Framework for the Australian health and medical research institute sector. He also Chairs the Melbourne Children's LGBTIQ+ Collective, driving inclusive policy and practice across the MCRI and the Royal Children's Hospital through community-led co-production. Ken is passionate about partnering with diverse stakeholders to amplify the impact of research, and ensuring that the voices of community are central in shaping policy and health outcomes.
