His research interests include providing evidence for emergency care of children, incorporating best care into clinical practice in emergency departments, and system monitoring to highlight variation in care and ensure sustainable change. Zeffie is currently the Director of the Victorian Infant Hearing Screening Program at the Royal Children's Hospital's Centre for Community Child Health, a senior clinical psychologist with the Royal Children's Hospital's Department of Adolescent Medicine and Department of Neurology, and a research officer with the Murdoch Children's Research Institute.

Dr Laila Ibrahim

Laila Ibrahim is a Consultant Paediatrician in General Medicine at the Royal Children's Hospital Melbourne (RCH), Clinician Scientist-fellow at the Murdoch Children's Research Institute (MCRI) and Honorary Lecturer at the University of Melbourne (UoM). Her main research interest and vision is in avoiding unnecessary hospitalisation in children. For her PhD, she conducted a randomised controlled trial (RCT) of home versus hospital intravenous antibiotics in children and developed a clinical scoring system to determine which children with cellulitis should be treated with intravenous antibiotics, both of which had an immediate translation into clinical practice and incorporated into national and international

clinical guidelines. She leads single site and multi-site research studies, answering research questions relevant to paediatric clinical care.

Dr Jonathan Payne

Associate Professor Jonathan Payne is co-group leader of the Brain and Mind Research Group at the Murdoch Children's Research Institute, a senior clinical neuropsychologist at the Royal Children's Hospital and an Honorary Principal Fellow in the Department of Paediatrics, University of Melbourne. His research aims to increase understanding of the neurobiological mechanisms underlying complex neurodevelopmental disorders by studying the cognitive, behavioural, and neurobiological phenotypes that arise in monogenetic syndromes.

A/Prof Rachel Conyers

A/Prof Rachel Conyers has a track record as a leader in both clinical paediatric oncology and childhood cancer late effects research. She is internationally recognised as the Principal Investigator of the Australian Cardio-Oncology Registry and Biobank – a multi-institute national project, spanning 13 tertiary adult and paediatric institutes. This project is centred on identifying risk attributes, whether this be genomic, imaging, proteomic or metabolomic, towards cardiac late effects of cancer therapy. In addition, she is a chief investigator of the Cardiac Toxicity Task Force for the Children's Oncology Group. This international task force is in place to regularly curate and investigate the current literature and incorporate into the Children's Oncology Group Late Effects Guidelines, used for follow up of late effects in both the adult and paediatric sectors world-wide.

A/Prof Conyers is also the Cardiac PI of the Ponte De Legno Working Group (Europe) who recently ran an international Delphi consensus on the unacceptable toxicities attributable to acute lymphoblastic leukaemia therapy, from which pharmacogenomic predisposition can be focussed (published in The Lancet). A/Prof Conyers' track record in research is demonstrated by attaining > \$2.5 million of competitive grant funding focussed primarily on pharmacogenomic predisposition and cardiac toxicity in paediatric cancer survivors. She has published 61 papers in her career, with > 1000 citations. A/Prof Conyers is a regular NHMRC reviewer and is on the scientific advisory committee and gene therapy committee for Maddie Riewoldt's Vision, a pioneering philanthropic organisation raising research funds for Bone Marrow Failure Syndromes.

Dr Claire Von Mollendorf

Dr Claire von Mollendorf is a medical epidemiologist currently working as a senior research officer in the New Vaccines and Asia-Pacific Research Groups at the Murdoch Children's Research Unit (MCRI). She has been with MCRI since 2017 and predominantly manages surveillance programmes in Mongolia. She also provides support for other group projects in the Asia-Pacific Region. Prior to this she worked in different research areas, including women's health, HIV and pneumococcal research, in South Africa. Her passion and involvement in research has spanned over a 17 year period and included adults and children, some vulnerable groups and ranged from clinical trials to observational studies. Dr von Mollendorf graduated with a Bachelor of Medicine & Bachelor of Surgery from the University of the Witwatersrand, South Africa, completed a BscMedScHons in Reproductive Biology from the University of Stellenbosch in South Africa and a Master of Science in Epidemiology (Distance learning) through the University of London (London School of Hygiene & Tropical Medicine). Her Doctor of Philosophy degree in Public Health at the University of the Witwatersrand explored the impact of pneumococcal conjugate vaccine introduction in South Africa on the epidemiology of Streptococcus pneumoniae. She has a joint appointment as a Senior Fellow within the Department of Paediatrics, University of Melbourne. She has co-supervised different levels of undergraduate and postgraduate students and has published as an author and co-author on pneumococcal disease and other topics in peer reviewed journals.

Ken Knight

Ken is a knowledge translation (KT), engagement and research impact specialist with over a decade's experience leading KT, engagement and research impact programs in health and government. Ken

currently leads an award-winning, multifaceted program to accelerate the application of knowledge and enhance the impact of research across the Murdoch Children's Research Institute (MCRI). He developed the inaugural Melbourne Children's Knowledge Translation and Impact training program and Chairs the MCRI Impact Working Group. Ken conducts research on KT and impact in health and medical research, and partners with researchers and programs to facilitate their stakeholder engagement and impact planning and practice.
