The Royal Children's Hospital (RCH) provides secondary and tertiary care to children and young people across the northern and western suburbs; specialist paediatric healthcare to the children of Victoria, Tasmania, southern NSW and parts of South Australia; and is the designated state-wide provider of services including paediatric trauma, rehabilitation and forensic medicine. As a quaternary centre for complex cardiac surgery and organ transplantation, the RCH cares for the sickest children from around Australia.

The hospital employs 4,500 staff and has an annual budget of \$540million. It moved to a new, multi-award winning building at 50 Flemington Rd, Parkville.

ROLE PURPOSE

The Registrar position comprises of many rotations throughout the Royal Children's Hospital and secondment hospitals including: Box Hill, Frankston, Geelong, Monash Children's Health, Northern, and Sunshine Hospitals. Rotation length varies from year to year however a standard term is 13 weeks.

This position provides experience in a wide range of ambulatory and inpatient clinical areas. To provide broad knowledge in the basic sciences and clinical practice of paediatric medicine. To provide experience in common clinical procedures. To develop clinical acumen and decision making skills, interpersonal skills and professionals skills. To develop non-clinical skills including critical appraisal, evidence-based practice, quality improvement skills.

KEY ACCOUNTABILITIES

Inpatients

- Medical management of patients within unit
- Clerking, record keeping including supervision of JRMOs in this task
- Admit new patients into the Unit

- Provide, support and advise JRMO in regards to managing the day to day progress of patients on the ward
- Ensure appropriate discharge plans are made and adhered to
- Determine investigations under your consultant's supervision
- Consider the financial implications of clinical practices
- Medical procedures and teaching of medical students

- Potential to develop as a Consultant Paediatrician (*i.e.* knowledge, judgement, organisation, interpersonal skills, communication, teamwork and empathy)
- Ability to practice at a high standard (*i.e. current clinical skills*)
- Must have completed JRMO and SRMO years or equivalent 2 years including 6 months neonatal experience
- Must be eligible for registration with Australian Health Practitioner Regulation Agency (AHPRA)
