# The Royal Children's Hospital

The Royal Children's Hospital's (RCH) vision is A world where all kids thrive.

RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.

RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. A full range of paediatric and adolescent health services are provided plus tertiary and quaternary care for the most critically ill and medically complex patients in Victoria. Tasmania, southern NSW and other states around Australia and overseas. The RCH is the only provider of heart transplant services and CAR T-cell therapy for paediatrics in Australia. RCH is an effective advocate for patients and their families with a particular focus on vulnerable children and increasingly, mental health in young people. The hospital also supports many health promotion and prevention programs. The Hospital has more than 6,000 staff, a budget of \$850M, 12 wards and 350 beds. Annually, the RCH has 300,000+ Specialist Clinic appointments, 90,000+ Emergency Department presentations and 20,000 elective surgeries.

#### **ROLE PURPOSE**

Vascular Anomalies is a rapidly expanding area with medically complex patients requiring multidisciplinary care. Paediatric dermatology is currently the most under-resourced large field of paediatrics, with an urgent need for increased clinical service provision. There is much overlap between these two fields and the clinical benefits of a combined fellowship are compelling. The Vascular Anomalies and Paediatric Dermatology Registrar provides the opportunity for a Paediatric Advanced Trainee to gain expertise in these fields. They will work in partnership with a multidisciplinary team, with close collaboration with general medicine, dermatology, plastic surgery, laser, ophthalmology, and interventional radiology departments. They will enhance the provision of specialist care to children with vascular anomalies and skin disease. The Registrar will be trained in research and management skills in Paediatric Vascular Anomalies and Paediatric Skin.

Role comprises of 3 weekly Outpatient clinics 1x Dermatology and 2x Paediatric Skin

\*\* In addition this role will participate in the Junior Medical Staff weekend on call roster as well as the SSU and Evening Medical Lead weekend roster (weekend commitment is approximately 1 in 5). Weekend shifts are paid in accordance with the applicable enterprise agreement.

# **Outpatients**

- Provision of clinical care in the outpatient setting in a supervised capacity in Vascular Anomalies, Paediatric Skin and Dermatology clinics
- Responsible for onward referrals, investigations, documentation and liaison with primary care providers

# **Short Stay Unit**

- Clinical care of acute general paediatric conditions for patients expected to require admission <48hrs
- Pivotal decision maker and responsible for admissions, discharges and clinical assessments/procedures
- Recognition and management of deteriorating patients

# **Evening Medical Lead**

- Acute clinical assessment and management of admitted patients including those under the care of subspecialty teams
- After hours leadership position across the hospital, involving coordination of workload and patient care and ensuring that the rostered junior medical staff are working collaboratively as a team
- Liaison with ED and Bed Manager as required
- Assist with medical admissions, assessments, and procedures for inpatients
- Participation in daily consultant led ward round of SSU patients (4-5pm)

• Completion of a research project in Vascular Anomalies

- Organisation and participation in the fortnightly Vascular Anomalies Teaching and Multidisciplinary meetings, including Journal club.
- Involvement in the teaching of medical students, paediatric residents, and registrars

- Online or in person participation at International Society of Vascular Anomalies workshops and paediatric dermatology meetings.
