Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. ## ROLE PURPOSE

To provide experience and training in paediatric General Medicine and is an excellent opportunity for an Australian College of Emergency Medicine (ACEM) trainee completing the joint training program in Paediatric Emergency Medicine to develop general paediatrics skills and experience.

This role provides an opportunity for exposure to multiple disciplines within General Medicine. It predominantly involves inpatient work and night medical lead work, and the successful candidate will have access to formal mentorship and leadership development within the role.

### Clinical Services

- Provision of clinical care in the inpatient setting, including liaison with other Gen Med Inpatient teams; Subspecialty teams; Nursing and Allied Health teams
- Opportunity to be first consultant on-call during receiving periods
- In Night Medical Lead capacity, support after hours junior medical staff, assist with workflow delegation,, admit and discharge patients, and assist with patient flow throughout the hospital
- Supervise and support junior medical staff during handovers Provision of clinical care in the outpatient setting, including liaison with both RCH outpatient units and external providers

### Education

- Attendance at Gen Med/RCH educational activities, including weekly education, journal club, grand rounds, Radiology meeting, M&M meeting and Gen Med weekly meeting
- Timely completion and compliance with all hospital mandated training
- Active contribution to education of junior staff, nursing, allied health and medical students as appropriate
- Undertake a clinical research project as applicable

### Non Clinical
