Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.</p> <p>RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. ROLE PURPOSE

The Rheumatology Fellow position will provide an advanced trainee in paediatrics with experience and training in Paediatric Rheumatology. The position will deliver clinical care and management to children and adolescents with rheumatological issues.

KEY ACCOUNTABILITIES

Clinical Services

- Provision of clinical care in the outpatient setting in a supervised capacity, including three general Rheumatology clinics per week; a monthly lupus clinic; a monthly uveitis clinic and monthly auto-inflammatory clinic and a fortnightly adult rheumatology clinic at the Royal Melbourne Hospital.
- Provision of clinical care in the inpatient, day medical and ward consult settings
- Triaging outpatient referrals and providing telephone advice to internal and external providers
- Take a lead role in the multidisciplinary Rheumatology team
- Liaison with other providers regarding patient care incl. RCH units, Allied Health and external providers

Education

- Attendance at Gen Med/RCH educational activities, including Rheumatology weekly education, journal club, grand rounds, Gen Med meeting and professorial meetings
- Timely completion and compliance with all hospital mandated training
- Active contribution to education of final year medical students, junior staff, nursing, allied health and visiting doctors as appropriate
- Coordination of the 6 monthly Mortality and Morbidity meeting
- Undertake clinical research project as discussed with mentor/supervisor

Non Clinical

- Timely and accurate completion of patient related documentation, including EMR encounters, ward round documentation, outpatient documentation and any other required documentation relevant to enhancing continuity of care
