RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.

RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. A full range of paediatric and adolescent health services are provided plus tertiary and quaternary care for the most critically ill and medically complex patients in Victoria. RCH is an effective advocate for patients and their families with a particular focus on vulnerable children and increasingly, mental health in young people. The hospital also supports many health promotion and prevention programs. The Hospital has more than 6,000 staff, a budget of \$850M, 12 wards and 350 beds. Annually, the RCH has 300,000+ Specialist Clinic appointments, 90,000+ Emergency Department presentations and 20,000 elective surgeries.

ROLE PURPOSE

To improve the health outcomes of children and young people with congenital, acquired or traumatic cranio-maxillofacial deformities requiring reconstruction, through clinical care and basic science and outcome research in consultation with the unit consultant staff. To develop the clinical skills of the fellow in both medical and surgical management of the complete range of paediatric OMS conditions. Successful applicants (fellows) have the opportunity and are encouraged to observe and participate in operating theatres and clinics of all disciplines within

the department. The fellow is also expected to complete a research project during the fellowship. This research project can be clinical, basic science or translational research.

KEY ACCOUNTABILITIES

- Clinical Care: responsible for patient care under consultant supervision, maintenance of acceptable standard of clinical care.
- Manage the day to day care of patients admitted under the Maxillofacial Surgery Unit of the department, and those referred to the department requiring ongoing involvement. Report any untoward outcome to the responsible consultant, and also communicate daily with the responsible consultant regarding the general progress of all patients on a seven day a week basis
- Conduct outpatient clinics when required, and where a consultant is not present, communicate with a consultant regarding any major management decisions
- Clinical and Basic Science research: maintenance of OMS surgery database in conjunction with the Registrar, develop and completion of research project culminating in presentation and publication.
- Teaching: teaching and supervision of Junior Medical Staff and assist with training of registrars, maintenance o appropriate relationships with junior and senior medical staff, nursing and administrative staff.

- MBBS and/or BDS equivalent tertiary qualifications
- Royal Australasian College of Surgeons Fellowship in OMS Surgery or equivalent qualification
- Previous experience in Paediatric OMS
