RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. ROLE PURPOSE

The purpose of this position is to:

- 1. Gain specialised knowledge and skills in the provision of paediatric ophthalmic care under the supervision of the consultant staff of the Royal Children's Hospital
- 2. Participate in clinical audits and research projects.

KEY ACCOUNTABILITIES

In patients

Day Surgery Patients:

- Inpatient consultation and appropriate care
- Pre-operative assessment.
- Supervise discharge (including completion of all relevant hospital documentation).

Emergency Patients:

- Assessment at admission.
- Daily review and discussion with responsible consultant.
- Supervise discharge process (as above).
- Coordinate inpatient consultation service and liaise with consultant staff
- Surgical care (as directed)

Ward Patients

• Assessment and management under supervision of a Fellow or Consultant

Outpatients

- See patients under supervision of the appropriate Consultant.
- · Record all findings, investigations, and management in the appropriate medical record.
- Clear communication with orthoptists and admin staff regarding any extra urgent cases added to a clinic

Administrative tasks

- Discharge summaries: Complete at time of discharge.
- Be part of the on-call roster with the Fellow and Training Registrars.
- Assist the triage team with patient queries.
- Assist the fellow with administrative tasks e.g. support letters for patients

Departmental meetings

• Attend review meetings as required and present prepared audits and case studies.

- Department Clinical Review meetings.
- Orthoptic workshops
