The Royal Children's Hospital

The Royal Children's Hospital's (RCH) vision is "A world where all kids thrive".

RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.

RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. A full range of paediatric and adolescent health services are provided plus tertiary and quaternary care for the most critically ill and medically complex patients in Victoria. Tasmania, southern NSW and other states around Australia and overseas. The RCH is the only provider of heart transplant services and CAR T-cell therapy for paediatrics in Australia. RCH is an effective advocate for patients and their families with a particular focus on vulnerable children and increasingly, mental health in young people. The hospital also supports many health promotion and prevention programs. The Hospital has more than 6,000 staff, a budget of \$850M, 12 wards and 350 beds. Annually, the RCH has 300,000+ Specialist Clinic appointments, 90,000+ Emergency Department presentations and 20,000 elective surgeries.

ROLE CONTEXT

Allied Health work across a broad range of single and multidisciplinary teams across RCH. The Allied Health directorate at RCH includes the following disciplines: Audiology, Child Life Therapy, Music Therapy, Nutrition, Occupational Therapy, Prosthetics and Orthotics, Physiotherapy, Social Work and Speech Pathology.



The Aboriginal and Torres Strait Islander Cadetship position has been developed to provide the cadet with pregraduation professional experience while undertaking studies towards an Allied Health course that leads to a nationally recognised qualification. Cadets will be offered the opportunity to work in a fixed term appointment with a required minimum of eight weeks full time equivalent (40 paid shifts) across 12 months. Paid work is flexible to suit the study requirements (and other commitments) of each individual Cadet.

ROLE PURPOSE

The Allied Health Assistant will work within the relevant Allied Health department or program to contribute to the clinical work and efficient operations of the department, under the delegation and supervision of Allied Health Professionals.

This may include supporting the relevant Allied Health professional with

- 1. delivering therapy to inpatients or outpatients,
- 2. maintaining therapy equipment and
- 3. varied patient related duties.

- Provide clinical handover to required standard

- Participate in professional development activities to ensure that best clinical practice is maintained
- Identify personal and professional development needs, and plan and implement strategies for achieving them
- Achieve and maintain competency in relevant skills in line with departmental requirements relevant to the role

- Provide child centered, family focused care through partnership with parents/ families as delegated by Allied Health professionals
- Work in collaboration with multidisciplinary teams
- Cooperate and work well with others in the pursuit of team goals
- Actively participate as part of a team to ensure ongoing excellence in service delivery and contribute to continuous improvement

- Apply well-developed verbal communication and interpersonal skills and attention to detail with the ability to interact with a variety of stakeholders

QUALIFICATIONS AND EXPERIENCE

Essential:

- Enrolled in an Allied Health course that leads to a nationally recognised qualification, including a bachelor's degree, diploma, graduate certificate, graduate diploma or master's degree
- Have progressed beyond the first year of study
- Have maintained a pass grade in all subjects
- Currently reside in Victoria or a cross-border community

KEY SELECTION CRITERIA

- Excellent professional, interprofessional, interaction and self-reflection skills to enable effective work with people of different personalities and backgrounds
- Motivated, with demonstrated enthusiasm and initiative
- An interest in working in paediatrics
- An ability to balance sometimes competing and conflicting priorities
- Strong computer literacy skills

OTHER REQUIREMENTS

- Employees are required to maintain a valid Working with Children Check throughout their employment
