# The Royal Children's Hospital

# **ROLE CONTEXT**

This role is part of the acute Speech Pathology team at RCH who provide services to inpatient and outpatient paediatric populations with communication and swallowing disorders. There is one part-time AHA within the Acute Speech Pathology Team. The AHA assists the speech pathologist in their practise. This involves a large proportion of work that is not patient-facing (e.g., equipment maintenance, resource development, preparation for clinics/therapy sessions, calling families etc), as well as some patient facing work that is under the guidance of a speech pathologist and within the scope of AHA practice.

# **ROLE PURPOSE**

The Speech Pathology Department at RCH provides services to both inpatient and outpatient populations in the areas of eating, drinking and swallowing, speech, language, voice, cleft and tracheostomy.

The Allied Health Assistant assists speech pathologists to provide optimal care to children with communication and swallowing difficulties in both inpatient and outpatient settings. A large proportion of this work involves maintaining therapy equipment and spaces, setting up for clinics, and resource development for patients and the team. The AHA may also assist in delivering therapy programs under the guidance of a Speech Pathologist.

### **KEY ACCOUNTABILITIES**

#### **Provision of Care**

- Maintain the Beverage Bay in Specialist Clinic for use by Speech Pathologists including ordering, collecting, maintaining, and auditing food/fluids products and equipment (e.g., specialist bottles and teats).
- Assist in preparation for clinics and appointments (e.g., preparing food/fluids for videoflur oscopy swallowing studies, developing resources, scoring screening assessments, gathering additional information)
- Assist in maintaining equipment and developing resources for patients and the speech pathology team (e.g., developing communication boards, programming assistive technology devices, iPad maintenance.
- Maintaining assessment and therapy test cupboards (tests, assessment forms,
- Provide clinical care prescribed by a Speech Pathologist to children and adolescents in inpatient and outpatient settings in conjunction with the therapists, patient and family
- Collect, record and access information in timely manner and ensure that it is relevant to the patient/client's workplace needs
- Put the patient/family at ease by clearly explaining upfront the healthcare activity/activities to be undertaken
- Ensure consent has been obtained and documented by the responsible practitioner
- Work within the scope of authority given by the patient/family with performing healthcare activities
- Constructively assist others to plan and prepare for clinical care
- Monitor the patient's response to treatment/intervention
- Provide feedback to treating health care professional any changes to the patient's status that could impact on future therapy/goals
- Seek guidance and assistance when required
- Participate in safely and quality programs that seed to reduce the causes of harm in healthcare
- Document information according to RCH guidelines

# **Collaborative Practice**

- · Negotiate appropriate boundaries with the patient/family and ways of working together
- Treat patients/families as partners in their own care
- Work in partnership with other health professionals towards common goals
- Understand own role and the roles of others in the provision and coordination of care
