## The Royal Children's Hospital

The Royal Children's Hospital's (RCH) vision is A world where all kids thrive.

RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.

RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. A full range of paediatric and adolescent health services are provided plus tertiary and quaternary care for the most critically ill and medically complex patients in Victoria, Tasmania, southern NSW and other states around Australia and overseas. The RCH is the only provider of heart transplant services and CAR T-cell therapy for paediatrics in Australia. RCH is an effective advocate for patients and their families with a particular focus on vulnerable children and increasingly, mental health in young people. The hospital also supports many health promotion and prevention programs. The Hospital has more than 6,000 staff, a budget of \$850M, 12 wards and 350 beds. Annually, the RCH has 300,000+ Specialist Clinic appointments, 90,000+ Emergency Department presentations and 20,000 elective surgeries.

## THE CARDIAC SURGERY DEPARTMENT

The Cardiac Surgery Department at the RCH is the sole provider of care for paediatric cardiac surgery for Victoria, Tasmania, South Australia and Northern Territory. The Cardiac Surgery Department performs over five hundred and thirty open heart surgeries a year. It holds the Nationally Funded Centre for paediatric cardiac transplantation and this includes a large program for LVAD and ECMO.

As one of the leading paediatric cardiac surgery programs in the world, our care relies on and includes clinical and technical excellence, innovation, clinical and experimental research and teaching of younger generations of surgeons. In partnership with the Royal Melbourne Hospital, it treats patients with congenital heart disease beyond their transition to adult care.



## **ROLE PURPOSE**

- The successful candidate will be a full-time member of our surgical team, performing surgery as main operator and assisting the ward and intensive care unit in the management of **paediatric** cardiac surgery patients at RCH.
- The candidate will also undertake surgical management of **adult** patients with congenital cardiac conditions at the Royal Melbourne Hospital, in line with the relevant service agreements.
- The candidate will be on-call one in four and be responsible for the collection of clinical data.
- Significant involvement in research and management of subspecialty is also expected.
- Suitable honorary appointments to the University of Melbourne and MCRI will be organised.

## **KEY ACCOUNTABILITIES**

- The Candidate must be technically expert in the skills of neonatal and infant paediatric cardiac surgery. Several years of experience as first operator in paediatric cardiac surgery is required as well as training/experience in adult cardiac surgery, especially for congenital cardiac conditions.
- The Candidate will participate in clinical research or clinical trial.
- The Candidate will demonstrate ethical decision making in achievements of organisational goals. Comply with and utilize procedures, policies, regulations & standards of the Royal Children's Hospital.
- The Candidate will be required to participate in the Cardiac Surgery weekly review and planning meeting, Combined Cardiology and Cardiac Surgery Conference, monthly Mortality & Morbidity Meeting, ICU daily access meeting, ECHO weekly meeting, research meetings, weekly grand rounds and daily ward rounds.

## **Procedure/Specialised Scope of Practice:**

- Surgery for congenital and acquired cardiac diseases in neonates, infants, children, and adolescents.
- Cardiac transplantation, including surgery in paediatric age group.
- All surgical activity related to cardiac failure (VAD and ECMO)
- All circulatory assistance related to sepsis (ECMO)
- Vascular surgery related to care of congenital cardiac patients.
- Lung and chest surgery related to care of patients with congenital cardiac conditions.
- All adult congenital cardiac surgery

# Other responsibilities:

- The Candidate will be in continuous contact with other consultant surgeons, theatre nurses, ICU personnel medical and nursing, ward doctors and nurses, cardiac administrative staff, Cardiology staff, medical senior and junior. JMO and HMO and Paediatric Trainees.
- The Candidate will provide supervision of junior medical staff and provision of training and education to the department's staff and medical students.
- The Candidate, in consultation with the Head of Department will ensure all services are maintained and delivered in line with the RCH-wide philosophy and culture of patient and family centred care, vision and values. They will work in accordance with the RCH policies and procedures including occupational health and safety, equal employment opportunity, confidentiality and ensuring staff under direct supervision are working within these guidelines.
- Be respectful of the needs of patients, visitors and other staff and maintain a professional approach to all interactions.
- Other duties consistent with the employee's skill level and classification.
- Be supportive of the functions and ideals of the relevant College and Governing bodies.
