## The Royal Children's Hospital

With more than 6,000 staff, 12 wards and 350 beds, the RCH is the major specialist paediatric hospital in Victoria, and also provides care for children and young people from Tasmania, southern New South Wales and other states around Australia and overseas.

We are the state's busiest paediatric Emergency Department, often experiencing more than 300 presentations on any given day. The RCH is committed to working with health services across the state and plays a significant role in many critical state and nationwide services. We work collaboratively with hospitals to deliver the right care, in the right place, at the right time, for the benefit of all Victorian children. ### **ROLE PURPOSE**

The purpose of this role is to provide high quality, evidence-based clinical and laboratory haematology services for patients of the Royal Children's Hospital and Royal Women's Hospital.

This role incorporates general duties as a senior medical staff member of the Clinical Haematology team, in addition, the RCH Anticoagulation lead will be responsible for an organizational approach to provision of high quality anticoagulation services across RCH, incorporating clinical governance and quality/ safety measures to improve outcomes and reduce errors related to provision of anticoagulation management in a tertiary/quaternary paediatric setting (incorporating support for surgery, VAD/ ECLS/ solid organ transplantation / complex cardiac services / PICU and NICU). This role requires Integration of clinical services with research activities undertaken in collaboration with other clinical teams across the hospital in additional to campus partners (Uni Melb and MCRI) as required.

#### **KEY ACCOUNTABILITIES**

### Anticoagulation lead

- Organization wide approach to anticoagulation (enhanced governance framework with focus on quality and safety), with a strong focus on high use areas including PICU/ NICU/ theatre/ VAD program/ECLS/Cardiac Services.
- Embed consultation, education/training, guideline development and compliance monitoring in high-risk clinical areas with strong linkage to clinical haematology
- Collaboration with haematology research program (bench to bedside approach to research agenda
- Assist with introduction of new anticoagulant agents (evidence based approach) in both inpatient and outpatient settings as required for best care for RCH patients and families
- Provide support for organization wide approach to CVAD devices / line care which often impact on anticoagulation

#### **Direct Clinical Care**

- Lead by example in delivering high quality clinical care for children and adolescents using the services at the Royal Children's Hospital and patients at the Royal Women's Hospital
- Work in partnership with other medical, nursing and medical scientists and other allied health professional staff to provide excellent medical and pathology services for inpatients and outpatients, within the employees' scope of practice
- Ensure that consultations, treatment plans and other aspects of care delivered are thoroughly documented to support ongoing care and communication and to satisfy medicolegal, administrative and billing requirements
- Participate in providing high quality pathology services at the Royal Children's and Royal Women's Hospital including routine and specialized haematology test reporting, communication and interpretation of results for clinicians, all pathology laboratory quality activities and transfusion medicine services.

## Practice improvement, quality, safety, compliance and governance

- Promote and maintain exemplary standards of clinical practice to ensure provision of high-quality services to patients
- Participate in the development, implementation, auditing and revision of treatment protocols and clinical guidelines to promote and ensure best practice
- Work in accordance with all Laboratory procedures and participate in Haematology quality assurance programs and activities
- Participate in service planning for the development and setting of targets, resource requirements and improvement priorities within the Department
- Work collaboratively with the multidisciplinary team to facilitate clinical service improvement through clinical audit and research
- Practice with a patient and family centred care focus and ensure that consumer input is welcomed and encouraged
- Maintain professional registration requirements including participation in recognised continuing professional development (CPD)
- Contribute to a culture of quality and safety through reporting of incidents (VHIMS) and participate in incident review

# Education, training and professional development

- Be aware of the clinical experience and proficiency of Junior Medical Staff delegated to deliver care and provide direct supervision as necessary
- Participate in teaching activities for medical, nursing and allied health staff and students across RCH.

### QUALIFICATIONS AND EXPERIENCE

Eligible for full registration as a specialist Medical Practitioner with the Australian Health Practitioner Regulation Agency

- Fellowship with the RACP (Haematology or equivalent)
- Fellowship with the RCPA (Haematology), or equivalent

#### **Essential:**

- Experience with clinical and diagnostic haematology in the newborn, paediatric, maternity and women's health context.
- Expertise in complex paediatric anticoagulation service provision,
- Previous experience in governance and quality management to assist with key activities for the anticoagulation lead component

### Other Requirements:

- Employees are required to undertake a National Criminal Record Check and a Working with Children Check prior to commencing employment
- Employees are required to maintain a valid Working with Children's Check throughout their employment
- A current, full drivers license for the State of Victoria which is appropriate for the type of vehicle being driven, and comply with any restrictions on their license (e.g. wearing glasses) while undertaking hospital duties (If applicable)
- Employees are required to maintain compliance with RCHs "Staff Immunisation Prevention of Vaccine Preventable Diseases" procedure.

- Demonstrated ability to deliver a high level of diagnostic haematology expertise and clinical care
- Extensive experience in the specialty of paediatric haematology (including complex anticoagulation).
- Highly developed organization and planning skills with the ability to change priorities according to acuity and demand
- Professional demeanor and strong approach to teamwork
- Participation in research
