ROLE PURPOSE
The purpose of this role is to provide a consultative specialist paediatric Medical Imaging services to referring doctors and to assist with promotion and advancement of knowledge, techniques and standards in diagnostic Medical Imaging and Nuclear Medicine. The comprehensive range of primary to quaternary level paediatric imaging procedures performed include paediatric ultrasound, general radiography, fluoroscopy, MRI and CT, interventional procedures and Nuclear Medicine including MR PET. Flexible sessional arrangements may be considered but need align with the operational needs of the department. Participation in the after-hours on call roster for diagnostic imaging and Nuclear Medicine and participation in department meetings and teaching is also expected as part of the role. Academic interests are encouraged.
