## The Royal Children's Hospital

The Royal Children's Hospital (RCH) has cared for the children and young people of Victoria since it was founded in 1870. As a tertiary and quaternary centre, the RCH cares for the most critically ill and medically complex paediatric patients in Victoria. In addition to providing a full range of clinical services, the hospital also supports many health promotion and prevention programs. With more than 6,000 staff, 12 wards and 350 beds, the RCH is the major specialist paediatric hospital in Victoria, and also provides care for children and young people from Tasmania, southern New South Wales and other states around Australia and overseas.

We are the state's busiest paediatric Emergency Department, often experiencing more than 300 presentations on any given day. The RCH is committed to working with health services across the state and plays a significant role in many critical state and nationwide services. We work collaboratively with hospitals to deliver the right care, in the right place, at the right time, for the benefit of all Victorian children. In April 2016, the RCH became the first Australian hospital to implement the world-leading 'Epic' electronic medical record (EMR). RCH has a strong focus on supporting the successful delivery of the Parkville Connecting Care program – a shared EMR with the Royal Women's Hospital, The Royal Melbourne Hospital and Peter MacCallum Cancer Centre.

## ROLE PURPOSE

As part of the Division of Surgery, this position exists to provide a quality imaging service to patients and referrers. As a general MIT the required roles include imaging modalities as per the current skills of the incumbent and to expand and improve those skills. Under the direction of the Chief MIT and deputies, the role contributes to the ongoing care of paediatric patients in spheres of diagnosis, disease monitoring and treatment. The goal is to maintain a consistent high standard of imaging in order to succeed in producing reliable, timely and important results which can make a difference.

## KEY ACCOUNTABILITIES

- Perform imaging examinations as per protocols to ensure consistency in diagnostic quality for both elective and emergency referrals;
- Undertake administrative duties required to maintain and complete patient imaging records;
- Be aware of and practice radiation safety protocols in order to adhere to the ALARA principle;
- Participate and train in specialist modalities to provide a quality service and roster flexibility.
- Participate in both internal and external training, education and research to maintain standards and professional development as required by AHPRA and government legislation.
- Maintain personal CPD requirements of the professional body overseeing MITs and appropriate registration.
- Be aware of and practice RCH requirements in regards to incident reporting to ensure continuous improvements to consumer service;
- In consultation with senior MITs be aware of and report equipment and plant malfunctions to ensure safety and service maintenance;

- Build and maintain relationships with key stakeholders to ensure high level service provision;
- Interact with patients and families in a professional and empathetic manner.

#### QUALIFICATIONS AND EXPERIENCE

##### Essential:

- Diploma or degree in Applied Science/Diagnostic Radiography as outlined for eligibility for membership ASMIRT
- Current membership of AHPRA
- Current Victorian DHHS radiation licence

##### Desirable

- Previous Paediatric experience either as qualified, student or intern MIT

##### Other Requirements:

- Employees are required to undertake a National Criminal Record Check and a Working with Children Check prior to commencing employment
- Employees are required to maintain a valid Working with Children's Check throughout their employment
- A current, full drivers licence for the State of Victoria which is appropriate for the type of vehicle being driven, and comply with any restrictions on their licence (e.g. wearing glasses) while undertaking hospital duties (If applicable)
- Employees are required to maintain compliance with RCHs "Staff Immunisation - Prevention of Vaccine Preventable Diseases" procedure.

- Able to work autonomously and as part of a team;
- A high level of written and oral communication, and interpersonal skills;
- Able to build and maintain working relationships with key internal and external stakeholders;
- Ability to organise and plan work effectively, adapting to changes as required.

- Balancing sometimes competing and conflicting priorities
