### **ROLE PURPOSE**

The purpose of this role is to provide a consultative specialist paediatric Nuclear Medicine services to referring doctors and to assist with promotion and advancement of knowledge, techniques and standards in Nuclear Medicine. The comprehensive range of primary to quaternary level paediatric imaging procedures performed include paediatric Nuclear Medicine including MR PET. Flexible sessional arrangements may be considered but need to align with the operational needs of the department. Participation in the after-hours on call roster for Nuclear Medicine and participation in department meetings and teaching is also expected as part of the role. Academic interests are encouraged.
