We are the state's busiest paediatric Emergency Department, often experiencing more than 300 presentations on any given day. We work collaboratively with hospitals to deliver the right care, in the right place, at the right time, for the benefit of all Victorian children. #### **ROLE PURPOSE**

This is an exciting opportunity to be involved in a new pharmacy service with the clinical oncology pharmacy team. The successful applicant will be involved in supporting the highly specialised oncology clinical pharmacists on the inpatient ward with admissions, discharges, supply management, production requirements, and data collection for quality projects. The aim of the new service is to improve medication safety to oncology patients, and to demonstrate sustainability of the service through cost savings.

## **KEY ACCOUNTABILITIES**

- Introduce and develop the pharmacy technician role on oncology ward to support the clinical pharmacists and improve medication safety.
- Provide comprehensive, professional, and high-quality technical support in the provision of pharmaceutical services to the oncology ward.
- Work independently at ward level, being able to prioritize own workload and refer to the clinical pharmacists where appropriate.
- Order, dispense and deliver in a timely manner non imprest medications to oncology inpatients, including drugs of dependence and chemotherapy as required by the ward.
- Be the key liaison point for nurses and pharmacists to order medications for oncology patients.
- Communicate with patients and care givers to illicit information for medication histories on admission.
- Update written procedures to reflect current processes and create new documentation where needed.
- Bring to the attention of the oncology ward pharmacists any supply problems to avoid missed doses.
- Monitor the wards medication room to ensure imprest supplies are relevant and storage conditions are safe.
- Check and assess inpatient medication supplies against the drug chart regularly to ensure medicines are current and returns are processed to reduce waste.
- Collect data on quality improvement projects for oncology patients.
- Manufacture sterile/non-sterile products and chemotherapy for oncology patients following the requirements of clean room working and aseptic technique.
- Co-ordinate orders and supply of required manufactured products for oncology inpatients.
- Adhere to relevant guidelines with regards to staff handling of hazardous and cytotoxic medications.
- Prioritize, dispense and co-ordinate discharge medications including administration charts to inpatients.
- Liaise with the pharmacists, medical and nursing staff regarding PBS requirements for prescriptions.
- Supply imprest medications to the oncology ward when the imprest technician is on leave.
- Assist the oncology outpatient team at times of staff shortages.
- Actively contribute to the development of the role and quality improvement initiatives within the oncology pharmacy department.
- Participate in the weekend and public holiday roster.
- Adhere to all legislative requirements, hospital guidelines, accreditation and professional standards.
- Actively participate in pharmacy and hospital education.

Assist in the provisions of the pharmacy service to any RCH patients at the direction of the senior pharmacy management.

# **QUALIFICATIONS AND EXPERIENCE**

### **Essential:**



- Qualified hospital Pharmacy Technician (completed certificate III or IV) or equivalent qualifications.
- Minimum 1 year work experience as a hospital medicines management Pharmacy Technician.
- Minimum 1 year work experience manufacturing products in a clean room environment including cytotoxic drugs.
- Computer literate with experience in using a pharmacy computer system for ordering and dispensing patient specific medications.
- Completed a Pharmacy Board approved aseptic and cytotoxic manufacturing course (or equivalent)

#### **Desirable:**

- Hospital Pharmacy Technician with a minimum 5 years work experience.
- Prior work with paediatric patients or cancer patients.
- Familiarity with the Pharmaceutical Benefits Scheme.
- Experience in previous cost saving initiatives or projects.

### Other Requirements:

- Employees are required to undertake a National Criminal Record Check and a Working with Children Check prior to commencing employment
- Employees are required to maintain a valid Working with Children's Check throughout their employment
- A current, full drivers licence for the State of Victoria which is appropriate for the type of vehicle being driven, and comply with any restrictions on their licence (e.g. wearing glasses) while undertaking hospital duties (If applicable)
- Employees are required to maintain compliance with RCHs "Staff Immunisation Prevention of Vaccine Preventable Diseases" procedure.

- Excellent communication skills.
- Computer literate.
