<p>The Royal Children's Hospital</p> <p>The Royal Children's Hospital's (RCH) vision is A world where all kids thrive.</p> <p>RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.</p> <p>RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. A full range of paediatric and adolescent health services are provided plus tertiary and quaternary care for the most critically ill and medically complex patients in Victoria, Tasmania, southern NSW and other states around Australia and overseas. The RCH is the only provider of heart transplant services and CAR T-cell therapy for paediatrics in Australia. RCH is an effective advocate for patients and their families with a particular focus on vulnerable children and increasingly, mental health in young people. The hospital also supports many health promotion and prevention programs. The Hospital has more than 6,000 staff, a budget of \$850M, 12 wards and 350 beds. ROLE PURPOSE

The Paediatric Emergency Physician will join the existing team of emergency department senior medical staff to provide leadership in all aspects of paediatric emergency medicine. Several fixed term positions available to provide clinical backfill for periods ranging 8-12 months. Limited capacity for contract extension to be negotiated.

- Participate in the clinical roster to directly provide and supervise the delivery of excellent emergency care.
- Perform the role in a manner required to achieve departmental quality metrics to ensure access to emergency care and efficient patient flow, contributing to a high performing and sustainable emergency department.
- Engage with other clinical stakeholders in the hospital to support the above accountabilities being met.
- Take on a non-clinical portfolio commensurate with the fraction appointed and lead the emergency department's performance in that area with the support of the Director.
- You will build relationships and mutual respect and trust amongst all members of the multidisciplinary emergency department team, and more broadly throughout the hospital.
- Establish and improve clinical links between the emergency department and other key stakeholders including other emergency departments, general practitioners, local paediatricians and inpatient services.
- Participate in educational training program in paediatric emergency medicine.
- Participate in research in paediatric emergency medicine

QUALIFICATIONS AND EXPERIENCE

- Completion of specialist training in paediatric emergency medicine under the Australasian College of Emergency Medicine or Royal Australasian College of Physicians, or comparable international qualification recognised by either of these colleges.
- Current registration as a Specialist Medical Practitioner with AHPRA.
