Annually, the RCH has 300,000+ Specialist Clinic appointments, 90,000+ Emergency Department presentations and 20,000 elective surgeries.

# **ROLE CONTEXT**

The Physiotherapy Department works within the Directorate of Allied Health and is comprised of Physiotherapists and Allied Health Assistants, providing tertiary level care to inpatients and outpatients at RCH. Our mission is to optimise children's health and function in partnership with families and provide evidence-informed physiotherapy care at the right time and in the right place.



The RCH Aquatic Therapy pool and program is operated and managed by the Physiotherapy Department, providing clinical aquatic physiotherapy to both public and NDIS-funded clients.

The Physiotherapy Department provides a clinical service seven days per week, including daytime and evening shifts.

## **ROLE PURPOSE**

The Grade 3 Physiotherapist for Aquatic Physiotherapy and Plagiocephaly will be responsible for the management and operation of the RCH Aquatic Physiotherapy Service as well as delivery of clinical services to children referred to the plagiocephaly clinic in a primary contract model. They will play a pivotal role in the ongoing development of the Aquatic Physiotherapy and Plagiocephaly services at RCH and will work with the department manager, staff across the Physiotherapy Department, and other key stakeholders across Allied Health and RCH.

The Grade 3 Physiotherapist will provide specialist physiotherapy services to children and adolescents as part of a multidisciplinary team at RCH across both the aquatic and land environments. The Physiotherapist, by working in close collaboration with medical, nursing and allied health staff at RCH will ensure that services provided to children at RCH are innovative, evidence-informed and provided in a child and family centred context.

This role will sit within a larger physiotherapy stream and will provide support and assistance in service delivery across other clinical areas within that stream as well as the broader department to assist with workload management as required, in line with appropriate skills and capabilities.

# **Provision of Care**

- Delivery excellent evidence-based practice physiotherapy assessments and interventions, particularly in the areas of aquatic therapy and plagiocephaly
- Maintain clinical documentation, records and data as per discipline specific guidelines and RCH procedures
- Develop, update and implement standards of practice, treatment protocols and local standard operating procedures for the aquatic physiotherapy service
- Plan for, and effectively manage, contingencies that may affect the performance of healthcare activities
- Implement and manage orientation and training to the aquatic physiotherapy service for new and existing staff
- Act to reduce error and sources of risk in own practice and as well as the broader department and healthcare setting
- Ensure timely provision of discipline services through appropriate prioritisation of stream and departmental caseload and patient needs
- Be a source of clinical expertise, advocacy and guidance within the clinical stream, across the department and within the broader multidisciplinary team
- Delegate healthcare activity to others according to their competency and scope of practice to ensure appropriate workload management and prioritisation across the department ensuring others can selfmanage and regulate their workload

- Minimum 7 years experience in health or related field
- Experience working in an acute tertiary hospital environment
- Experience working in an acute paediatric setting
- Demonstrated knowledge and expertise in the area of aquatic physiotherapy
- Demonstrated experience in education and supervision of students and less experienced physiotherapists

- Excellent professional, interpersonal, interaction and self-reflection skills to enable effective work with people of different personalities and backgrounds
- The ability to motivate children of different ages and abilities
- Be an advocate for patients and their families
- Experience in supervision and clinical leadership of physiotherapy staff and students
- Demonstrated ability to work in an acute care time-frame, manage competing demands and to appropriately prioritise and manage a caseload
- Excellent time management skills and high degrees of flexibility
- Demonstrated ability to function independently and collaboratively with evidence of good interpersonal skills and experience working in multidisciplinary teams
- Experience in continuous quality improvement, service development and leadership, including critical reflective practice
- Excellent computer literacy skills
