<p>The Royal Children's Hospital's (RCH) vision is A world where all kids thrive.</p> <p>RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. ROLE PURPOSE
<p>The Physiotherapist (Grade 2) will provide specialist inpatient and ambulatory- rehabilitation in partnership with children and families who require interdisciplinary, goal-focused innovative care.</p> <p>The Physiotherapist is responsible for ensuring a best-practice approach to the delivery of rehabilitation, focusing on the child's needs in the context of everyday activities and lifetime opportunities, empowering children to create their goals and own their rehabilitation journey. They will create strong partnerships within and outside The Royal Children's Hospital and value diversity of opinion, values, background and life experiences.</p>

<p><b>Provision of Care</b></p> <ul style="list-style-type: none"> <li>• Deliver excellent evidence-based practice Physiotherapy assessments and interventions in an inpatient and ambulatory rehabilitation setting.</li> <li>• Continually evaluate patient management for effectiveness, efficiency and quality and modify plans appropriately.</li> <li>• Ensure timely provision of physiotherapy services through appropriate prioritisation of own caseload. Develop treatment goals and plans in conjunction with the patient, their families and interdisciplinary team members, focussing on maximising participation in lifetime everyday activities and lifetime opportunities.</li> <li>• Prepare reports and provide effective verbal and written feedback to referrers, patients, and others, as appropriate to level of development.</li> <li>• Work effectively and collaboratively as part of a multidisciplinary team to establish common goals and to develop and offer best care to children and families, ensuring that patient care is integrated and effective.</li> <li>• Consider different points of view and compromise, where necessary and appropriate, to reach consensus.</li> <li>• Establish therapeutic relationships with patients and families that are goal directed and recognise professional boundaries and power imbalances.</li> <li>• Communicate effectively with patients and families to ensure their understanding, and that their needs and views are included in treatment, care plans and actions.</li> <li>• Conduct appropriate clinical handovers and arrange for follow-up to ensure patient care is maintained</li> <li>• Develop and update treatment protocols for areas of own clinical practice</li> <li>• Maintain accurate documentation of all patient related activity, including completion of all system required data and detailed medical record documentation in keeping with department, hospital, professional and legal requirements.</li> </ul>
