<p>The Royal Children's Hospital's (RCH) vision is A world where all kids thrive.</p> <p>RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. - Fulfil duty of care while understanding and practicing within own scope of practice in accordance with Australian Nursing and Midwifery Council guidelines.

- Conduct comprehensive and systematic mental health nursing assessment to improve the quality of nursing care.
- Use a range of clinical measures and semi-structured assessment techniques to collect relevant and accurate data.

- Determine agreed priorities for improving the mental health needs of individuals, families and/or carers and the milieu.
- Provision and implementation of quality clinical mental health care.

- Plans for continuity of care to achieve collaboration between the young person, their families/carers and out-patient clinicians to enable expected outcomes.
