# The Royal Children's Hospital

RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.

RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. A full range of paediatric and adolescent health services are provided plus tertiary and quaternary care for the most critically ill and medically complex patients in Victoria. ## **ROLE PURPOSE**

Theatre technicians are an integral part of the perioperative team. Under direction of nursing, anaesthetic, and surgical staff to deliver safe patient care within operating theatres including setting up the environment, transporting and positioning the patient and cleaning and maintaining the theatre equipment and environment.

Theatre technicians provide advanced clinical skills in all specialised areas of theatre and to undertake a training and mentoring role for new and inexperienced technicians.



#### **KEY ACCOUNTABILITIES**

- Ensure that all aspects of OH&S and infection control principles are adhered to and integrated into all work practices.
- Contribute to an environment of multidisciplinary teamwork, maintaining a flexible approach to working in all specialised areas of the Royal Children's operating suite.
- To test, use and maintain equipment and technology that is required for surgery, and which falls within the technician's responsibility.
- To prepare and maintain the operating room environment to ensure safe and efficient operating during surgery and subsequent procedures.
- Undertake all technician duties as listed in the technician position description. Assist technicians in other operating rooms as required.
- Use problem solving strategies to resolve workplace issues as they arise.
- Participate in orientation of new / casual staff, acting as a role model and mentor.
- Assist with the supervision, training/mentoring of other technicians and as required undertake clinical tutor role.

## **QUALIFICATIONS AND EXPERIENCE**

- Certificate 3 & 4 in operating theatre technical support.
- Desired prior experience as a Theatre technician.
