<p>The Royal Children's Hospital's (RCH) vision is <i>A world where all kids thrive</i>.</p> <p>RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.</p> <p>RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. A full range of paediatric and adolescent health services are provided plus tertiary and quaternary care for the most critically ill and medically complex patients in Victoria, Tasmania, southern NSW and other states around Australia and overseas. The RCH is the only provider of heart transplant services and CAR T-cell therapy for paediatrics in Australia. RCH is an effective advocate for patients and their families with a particular focus on vulnerable children and increasingly, mental health in young people. The hospital also supports many health promotion and prevention programs. The Hospital has more than 6,000 staff, a budget of \$850M, 12 wards and 350 beds. Annually, the RCH has 300,000+ Specialist Clinic appointments, 90,000+ Emergency Department presentations and 20,000 elective surgeries.</p> <p>We work collaboratively with hospitals to deliver the right care, in the right place, at the right time. ROLE CONTEXT
<p>You will be part of the acute Speech Pathology team at RCH providing services to inpatient and outpatient paediatric populations with communication and swallowing disorders. Speech Pathologists work in a range of clinical areas including swallowing, feeding, speech, language, voice, cleft palate, and tracheostomy. We see children across inpatient wards (e.g., General Medicine, Neurology, Respiratory, Neonatal Intensive Care, Paediatric Intensive Care). Speech Pathologists also participate in outpatient clinics relating to communication development as well as swallowing. These include large multi-disciplinary clinics, joint clinics with 1-2 other health professionals, as well as speech pathology-only clinics.</p>

ROLE PURPOSE
<p>The Grade 2 Speech Pathologist is responsible for the delivery of high quality and accountable clinical speech pathology services to the allocated caseload/s. This may include, but not be limited to, inpatients and outpatients presenting with communication and swallowing disorders from a variety of aetiologies. The position is responsible for providing clinical speech pathology services to patients allocated by a Senior Clinician and/or the Manager, Speech Pathology.</p> <p>Speech Pathology recognises that strong community partnerships and promotion and advocacy for children with communication and swallowing disorders are priorities. It is expected that the Grade 2 Speech Pathologist participates in these initiatives to ensure that provision of clinical services meet the needs of the children and their families.</p>

- Demonstrated interpersonal skills and an ability to communicate with multiple stakeholders in a professional, timely, and efficient manner (e.g., families, colleagues, managers)
- Demonstrated strong analytical, written skills; and the ability to keep accurate, timely documentation relating to patient care and department processes
- Demonstrated ability to work flexibly in a fast-paced and dynamic environment covering a number of caseloads as directed
- Demonstrated ability to educate patients/parents/discipline staff/ multidisciplinary team and members of the wider community to minimise risk and promote successful outcomes in patient care
- Demonstrated ability to work under supervision, improving performance through supervisor feedback and reflective practice
- Commitment to Quality Improvement principles, and evidence of initiation, implementation, and completion of projects
- Ability to assist in supervision of Grade 1 speech pathology staff, allied health assistants, and students.
- High levels of motivation, enthusiasm, and initiative
- IT/computer proficiency and literacy.
